

America 250 Oregon Grant

A GRANT FROM THE AMERICA 250 OREGON COMMISSION

Purpose

The America 250 Oregon Commission, in order to meet its mission to coordinate, provide guidance, and ensure that Oregon's official observance of the 250th anniversary of the founding of the United States is inclusive and shares the histories of Oregon's diverse populations, including the histories of the Indigenous peoples who have resided here since time immemorial is offering a grant for work related to the commemoration of the anniversary. The funding supports projects associated with the recognition of the semiquincentennial anniversary of the establishment of the United State of America.

Applications will be accepted in four cycles of funding. The grant is awarded on a **first come, first served** basis.

Eligibility

Organizations

ELIGIBLE

- Nonprofit organizations incorporated in the State of Oregon with a legally constituted board of directors or trustees.
- Local governments
- Public schools
- Universities and colleges
- Federally recognized Tribes in Oregon

NOT ELIGIBLE

- Individuals
- Religious organizations
- For-profit organizations
- State and Federal agencies

Number of awards per organization

Organizations may be awarded only once by this grant program. An organization that has received an award in any of the first three award cycles, is not eligible for funding in the fourth and final cycle.

Projects

Project Types

- Events, exhibitions, and programming
- Collections processing and development (including acquisition)
- Research and interpretation

Project Requirements

- All events, exhibitions, and programming must be accessible to the public. K-12 public schools can offer programs to students without inviting the general public.
- Funded projects may not be primarily intended as fundraisers, but may charge a fee.
- Projects must support the America 250 Oregon mission to ensure that Oregon's official observance of the 250th anniversary of the founding of the United State is inclusive and shares the histories of Oregon's diverse populations, including the histories of the Indigenous peoples who have lived here since time immemorial and align with one or more of the seven guideposts of America 250 Oregon.
 - To inspire Oregonians to participate in the forming of a more perfect union.
 - To highlight the importance of civics and history education in building a better future.
 - To highlight the work of Oregon's many history and heritage organizations.
 - To encourage a robust, thorough, and honest examination of our collective history.
 - To celebrate the unique traditions, arts, and cultures of communities throughout Oregon.
 - To honor the service and sacrifice of made by Oregon veterans.
 - To celebrate the power of place through Oregon's remarkable landscapes and scenic beauty.

Financial Information

Award Amount

The America 250 Oregon Commission originally allocated \$100,000 of the funding provided by the Oregon State Legislature toward this grant program. An additional \$60,000 has been approved for a fourth and final grant cycle.

- Awards will be up to \$3000 each.
- 50% of the funds are slated to be awarded to organizations in rural communities. For the purposes of this grant a rural community is under 30,000 in population and outside the Portland Metro urban growth boundary.

Match

No match is required.

Use of Funds

Funds can be used for equipment purchase, staffing, materials, supplies, volunteer support, promotion and marketing, and other costs directly associated with the funded project.

Grant Coordination

Oregon Heritage and Oregon Historical Society have teamed to coordinate the grant for the America 250 Oregon Commission. Oregon Heritage is coordinating the application, selection, and reporting processes. Oregon Historical Society (OHS) will disburse the funds to Grantees.

Grant Process

The America 250 Oregon Grant is a noncompetitive grant. Organizations apply using an online form that requires basic organizational, budget, and project information.

A PROJECT AND ORGANIZATION THAT MEETS THE GRANT ELIGIBILITY AND REQUIREMENTS WILL BE AWARDED FUNDS BASED ON THE ORDER OF SUBMISSION UNTIL FUNDS ARE FULLY ALLOCATED FOR EACH CATEGORY (URBAN AND RURAL) AND FOR EACH CYCLE.

\$60,000 is available in the fourth and final cycle, \$30,000 each for rural and urban communities. At the end of the fourth and final cycle application period, remaining funds in the rural or urban categories may be awarded in the other category.

Timeline

There will be four grant application periods, allowing for organizations that have not yet prepared a project to have an opportunity to have access to funds in the first-come, first-served grant process.

APPLICATION CYCLE 1

September 15 – November 1, 2025 or until funds are expended

APPLICATION CYCLE 2

January 5 – March 1, 2026 or until funds are expended

APPLICATION CYCLE 3

March 4, 8:00 a.m. – April 3, 2026 or until funds are expended

APPLICATION CYCLE 4, FINAL

April 13, 9:00 a.m. – May 11, 2026 or until funds are expended

GRANT PERIOD

The grant period begins when the grant agreement is signed. Grant funds will be distributed upon award. Only work completed during the grant period which is between the agreement start date and June 30, 2027 qualifies.

Award Process

All applications will be reviewed by an Oregon Heritage Commission advisory panel to ensure the project meets eligibility requirements. Applications are collected every two weeks during the application period. The review could take up to three weeks.

If approved, the applicant will be sent a grant agreement for signature before award funds are distributed.

Project Requirements, Completion and Reporting

GRANT REQUIREMENTS

- Grant funds must be used as proposed in the application.
- Project materials must acknowledge the America 250 Oregon Commission and include its logo.
- Grantees must complete a final report.

GRANT DEADLINE

The deadline to complete projects and submit reports is June 30, 2027.

REPORTING

Grantees must submit a final grant report responding to the following questions.

- What was the public benefit of the project?
- Who participated in the activity?
- About how many people participated in the activity?
- Submit 3-5 photos of the activity.
